**TERMS AND CONDITIONS**

1. Information on how to enter and the prize(s) form part of these Terms and Conditions.
2. Participation in this promotion is deemed acceptance of these Terms and Conditions.
3. The promotion is only open to Australian residents aged 18 years or over.
4. Employees (and their immediate families) of the Promoters, and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex- spouse, de-facto spouse, child, or stepchild (whether natural or by adoption), parent, step- parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, stepbrother, stepsister or first cousin.
5. Promotion begins at 10am AEST on Saturday 14 February 2026 and closes at 1pm AEST on Saturday 14 February 2026, or when allocation of prizes is exhausted.
6. To be eligible, individuals must complete the following steps during the Promotional Period:
  - a. Spend \$30 in one transaction at Capri on Via Roma specialty retailers, or \$100 at Harris Farm at Capri on Via Roma, on Saturday 14 February 2026, and
  - b. Be one of the first 100 customers to present a valid receipt to the Love, Capri promotion desk between 10am-1pm, and
  - c. Complete the prize collection form including full name, email address and postcode to claim a free Pauls Chocolates Chocolate Heart.
7. One entry per customer during the Promotional Period. Entrants are only entitled to receive one (1) prize.
8. By participating in the promotion, entrants agree to receive marketing communications from Capri on Via Roma. Entrants can opt out at any time.
9. A valid receipt should be original, undamaged and clearly display the retailer name, date of purchase and amount spent. Damaged, duplicated or photocopied receipts will not be accepted.

The Promoters reserve the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoters have reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoters discretion. Failure by the Promoters to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoters' legal rights to recover damages or other compensation from such an offender are reserved.

Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoters (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoters' control); (b) any theft, unauthorised access or third party interference; (c) any entry that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoters) due to any reason beyond the reasonable control of the Promoters; (d) any variation in gift value to that stated in these Terms and Conditions; (e) any tax liability incurred by an

entrant or (f) use of/taking of a prize.

The Promoters collect personal information ("PI") in order to conduct the promotion and may, for this purpose, disclose such PI to third parties, including but not limited to agents, contractors, service providers, gift suppliers and, as required, to Australian regulatory authorities.
